- Event Format : The Asia/Oceania Qualifying zone will adopt a format of play designed to give all teams the best possible chance to qualify but this will be confirmed at a later date, when precise entry figures are known
- Hospitality : The host will provide accommodation and meals free of charge for each team entering (maximum 3 players and 1 non-playing captain per team).

All teams have to be present for compulsory group photograph at 8:00 am on 2<sup>nd</sup> May 2006. Players are requested to bring along their ***national flag*** of their respective countries.

Airport pick up : All players who advise us of their flight number and time of arrival will be met at the **Kuching International Airport (Sarawak)** on arrival flights before 12 midnight and transferred to Merdeka Palace Hotel, Kuching. Please fax or e mail arrival information well in advance to the Organising Secretary.

Rules : The tournament will be conducted in accordance with ITF Rules

Code of Conduct : The ITF code of conduct of 'ITF Junior Team Competition' will be enforced. (In entering the tournament, the player automatically grants Sarawak Lawn Tennis Association the right in perpetuity to make use and show pictures of him/her motion of skill taken during the competition without compensation.)

Visa letters : All invitation letters required for processing visas from each respective country must be requested at 2 weeks before start of event. A valid fax number must be furnished.
